The project was budgeted at \$45K coming in approximately \$5K less.

We are looking for an open weekend in order to perform the painting.

<u>Bocce Courts</u>: Presented by Paolo He is working on collecting fees for the lockers and the banners.

Kitchen:

Mary Ann presented that Donna is now the kitchen manager for the club. She is working on all party planning from start to finish. Private parties have been happening since July. There have been 2 members dinners.

Bar:

President's Report:

Moment of silence taken for those members who passed away Dave thanked Officer's, Trustees and Volunteer's for getting us through COVID. President covered off on the sexual harassment claim that has been raised against the club. An outside attorney has been brought in to provide a full investigation. HBC is working within the letter of the law regarding this topic. Ongoing updates will be provided to the membership.

Italian classes have begun again at the HBC for both children and adults. The class is split from Casa Italia. Reasonable pricing

Election for November:

The November election – President, Secretary and 3 Trustees. The election will be on 11.14.21. The Trustees will need to discuss procedures. There will be in person and mail in ballots. The candidates forum will be on 10.24.21.

Our election supervisor will be Dee Dee Nebling. Confidentiality, trust and neutrality are all important aspects in the election.

There is a sign-up board in the Club for anyone who wants to run for a Officer or Trustee position. In order to run for a position you must be a member for 1 year. In order to vote you must be a paid member for 2020 and 2021

Mask Policy:

A review was give of the current mask policy.

Bylaws/New Business:

We could not vote on the Bylaw change regarding the increase in dues as we did not have a quorum. A discussion was had on the membership dues and this would change for only new members. \$125 to \$250 Couples - \$200 to \$400

The FOB cost would be included. This would not go into effect until 11.14.21.

We would make every effort to give renewal to current members before this date.

Question came up on looking into implementing auto-renew of memberships.

Comment came up about tracking new memberships after we increase the cost.

A mock vote was taken most voted in favor of the dues increase, however those who did not vote in favor asked us to be careful in considering this type of increase in dues.

We could do this as a 1 year trial.

Late Fee do we want to use this type of charge.

From Bruce Bertucci – the entire club should be vaccinated as well as guests needig to show a vaccine passport. Bruce further stated that this will happen in his 2 leagues.

Marzio Piagentini in agreement. - How will we handle this during the parties?

Luigi Lunardi - members and guests we are still having trouble enforcing the policy regarding mask wearing ..

Steve Thornberry – After the break through case many people did not attend the following week. People went to get tested. Steve agreed with Bruce.

Paul Trogi – brought up a question about air filtration system in the Bocce Courts?

Michelle Holleman a good idea, and it sends the message that we are concerned about our membership.

Piero Amidei– In Italy you cannot go anywhere unless you are vaccinated

Board shared the motion that had been made that all league players need to be vaccinated. The enforcement of this policy will need to be done throughout the League President's and Trustees. Stronger language and communication might be needed regarding this policy.
